The Rector of the University of Yaounde 2 announces:

A recruitment of forty (40) auditors on file study to the Professional Master's in Economic Policy Management is opened to the Economic policy Management training program (EPM) for the academic year 2024 - 2025.

**I. Master 2 in University of Yaoundé II-SOA**

Twelve (12)-month training course, delivered by the University of Yaoundé II-SOA with teacher-researchers as well as national and international professionals, and comprising thematic modules on the design, analysis, monitoring-evaluation and impact assessment of public policies in the specific context of developing countries and the Sustainable Development Goals.

**II. Admission to the program**

Candidates must meet the following requirements:

- Higher education degree, Master 1 level (Higher education, Bac+4) required;
- At least 2 years' experience in a position involving the development, implementation, monitoring-evaluation or impact assessment of public policies;

**III. File composition**

The application file can be submitted to the GPE Secretariat or sent in accordance with the following instructions no later than January 31, 2025:

- As a single file in PDF format, respecting the order of the parts requested (see 1<sup>st</sup> and 2<sup>nd</sup> block);

**1<sup>er</sup> block : preliminary parts**

- An application stating the candidate's motivations, professional experience and availability for training;
- A curriculum vitae ;
- A receipt for 25,000 FCFA paid into account BANGE BANK CAMEROUN 10040 01003 38501008001-16, representing the application fee (non-refundable).

**2<sup>ème</sup> block : required documents**

- A certified copy of the highest diploma less than three (03) months old;
- A certified copy of the birth certificate less than three (03) months old;
- Certified copies of transcripts from the first year up to the highest diploma presented;
- A letter of recommendation from academic or professional circles.

Applications that are incomplete, late or signed at a police station will not be accepted. Documents legalized by an administrative or municipal authority must be dated within three (03) months of the date of submission. #### IV. Program financial terms

Training can be financed by the applicant, his or her administration or any other development support partner. The University of Yaoundé 2 grants a limited number of scholarships to Cameroonian students.

NB: The top graduate of the cohort will be awarded a stay with a partner organization of the Economic Policy Management (GPE) program, fully funded by the GPE.
