Economic Policy Management (EPM) training program Call for applications for the recruitment of the 3rd Cohort of the Master in Data, Economics and Development Policy (MDEDP), academic year 2024 - 2025

The Rector of the University of Yaoundé 2 announces:

A recruitment of thirty (30) students on the basis of portfolio study in the first year of the Master in Data, Economics and Development Policy (MDEDP) is open to the Economic Policy Management Training Program (GPE) for the 2024 - 2025 academic year.

I. Master 2 in University of Yaounde II-SOA

Two-year training course, delivered by the University of Yaoundé II-SOA with national and international teacher-researchers, professionals from national and international institutions, and comprising thematic modules on economics/management, mathematics, statistics, computer science, econometrics, practical work and guaranteed professional internships.

II. Admission to the program

Candidates must meet the following requirements:

- Graduates from higher education, Bachelor's degree level (Bac+3) required, preferably in economics/management or an equivalent degree (Statistical Works Engineer, Statistics engineer, Agricultural Science Engineer ...), mathematics, computer science or any other field that highlights the necessary prerequisites for this training;
- Good grades in Mathematics, Statistics and Computer Science throughout your academic career.

III. File composition

The application file can be submitted to the GPE Secretariat or sent according to the following instructions no later than January 31, 2025:

- As a single file in PDF format, respecting the order of the parts requested (see 1st and 2nd block);

- A request for admission addressed to the Rector of the University of Yaoundé, stating the applicant's reasons for applying;
- A curriculum vitae ;
- A receipt for 25,000 FCFA paid into the **BANGE BANK CAMEROUN** bank account **10040 01003 38501008001-16** representing the application fee (non-refundable).

2^{me} block: required documents

- A certified copy of the license dated within the last three (03) months;
- A certified copy of the transcripts of the Baccalaureate and the 3 university years;
- A certified copy of the birth certificate less than three months old;

Applications that are incomplete, late or signed at a police station will not be accepted. Documents authenticated by an administrative, municipal or academic authority must be dated within three (03) months of the date of submission.
