



PRESS RELEASE



The Rector of the University of Yaoundé II-Soa hereby informs the public that applications are open for the recruitment of **thirty (30) auditors**, through a competitive entrance examination, into the **Professional Master's Degree in Economic Policy Management (Master 2)** for the **2026–2027 academic year**, under the **24th Cohort** of the **Economic Policy Management (EPM) Training Programme**.

The programme is a **twelve (12)-month Master's degree** awarded by the University of Yaoundé II-Soa. Courses are delivered by national and international lecturers, researchers and professionals, and include thematic modules on the design, analysis, monitoring, evaluation and impact assessment of public policies, particularly in the context of developing countries and the Sustainable Development Goals. Teaching is conducted both **online and in person**, and the programme is open to professionals from Central African countries and the Great Lakes Region.

Applicants must hold at least a **Master 1 degree (Bac+4)** in Higher Education and have a minimum of **two (2) years of professional experience** in policy formulation, implementation, monitoring and evaluation, or public policy impact assessment.

Applications must include the following documents:

1. Preliminary documents

- An application letter addressed to the Rector of the University of Yaoundé II-Soa, stating the applicant's motivation;
- A Curriculum Vitae (CV);
- Proof of payment of the **25,000 FCFA** non-refundable application fee into one of the following bank accounts:

2. Required supporting documents

- A certified copy of the highest academic qualification;
- A certified copy of the GCE Advanced Level Certificate (or equivalent);
- Certified copies of academic transcripts from the first year to the highest degree obtained;
- A certified copy of the birth certificate;
- A letter of academic or professional recommendation.

Complete application files must be submitted **no later than October 30, 2026**, either:

Applicants may also complete their online registration by filling out the application form available at <https://traininggpe.edocsflow.com/> and subsequently submit the required supporting documents in accordance with the provisions of this Press Release.

Training costs may be covered by the applicant, their employer or any other development partner. In addition, the University of Yaoundé II-Soa may grant a limited number of financial facilities to eligible Cameroonian students.

The **top graduate of the cohort** will benefit from a **fully funded study stay abroad** at one of the EPM Training Programme's partner institutions. Furthermore, under the Programme's partnership with the **World Bank**, outstanding students may be offered academic internship opportunities.

The recruitment schedule is as follows:

- **October 30, 2026:** Application deadline;
- **November 5–6, 2026:** Candidate interviews;
- **November 13, 2026:** Publication of the list of successful candidates;
- **November 16, 2026:** Welcome and orientation of admitted auditors;
- **November 17, 2026:** Beginning of the academic year for the **24th Cohort**.
